Summary

It is requested that the County Board approve the attached resolution to accept and approve final payment disbursement of our 2015 Aggregate Surfacing Contract.

Background

This contract was for 16.2 miles of crushed rock surfacing on County Roads 42, 45, 46, and 55. The contractor for this project was Kielmeyer Construction Inc., of Nerstrand, MN. Work commenced on June 22, 2015, and was completed on July 16, 2015. The revised contract amount, to include CSAH 17 and CR 57, was \$104,668.80. Final contract amount is \$99,584.18. Final payment to the contractor is \$4,979.21. Completed contract amount is 95.1% of the revised contract amount.
