Summary

It is requested that the County Board approve the attached resolution to accept and approve payment of our Seal Coat Contract.

Background

This contract was for 21.8 miles of seal coating on CSAH's 6, 7, 9, 10, 11 and CR's 48, 50, 53, and 68. The contractor for this project was Fahrner Asphalt Sealers, LLC out of Eau Claire, WI. Work commenced on July 21st, and was completed on August 7th. The revised contract amount, to include CSAH 5, was \$518,484.76. Final contract amount is \$464,261.38. Final payment to the contractor is \$23,213.07. Completed contract amount is 89.5% of the revised contract amount.
