Summary

It is requested that the County Board approve the attached resolution to accept and approve payment of our Traffic Marking Contract.

Background

This contract was for 229 miles of traffic marking on various CSAH's and CR's. The contractor for this project was Traffic Marking Service, Inc from Maple Lake, MN 55358. Work commenced on May 26th and was completed on September 21st. The revised contract amount, to include an additional 36.2 miles, was \$189,831.60. Final contract amount is \$181,919.36. Final payment to the contractor is \$9,095.97. Completed contract amount is 95.8% of the revised contract amount.
